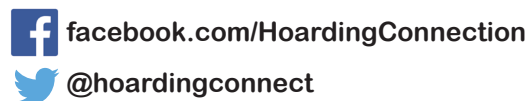

## Gary Patronek, VMD, PhD

Dr. Patronek is a veterinarian and epidemiologist. He currently works as an independent consultant and is also an Adjunct Professor at the Cummings School of Veterinary Medicine at Tufts. He founded the **Hoarding of Animals Research Consortium (HARC)**, a multidisciplinary group of investigators who conducted much of the initial research concerning animal hoarding. The work of HARC was instrumental in the mention of animal hoarding in the new hoarding disorder included in DSM-5 in 2013.



He has also been a shelter director, Vice President for Animal Welfare at the Animal Rescue League of Boston, and was formerly the Director of the Tufts Center for Animals and Public Policy.

Dr. Patronek has published over 50 peer-reviewed papers and textbook chapters, many of which deal with animal welfare and shelter issues. He was one of the authors and editors of the *Guidelines for Standards of Care in Animal Shelters* put forth under the auspices of the Association of Shelter Veterinarians and is one of three co-editors for the new book *Animal Maltreatment: Forensic Mental Health Issues and Evaluations* published by Oxford University Press in October 2015.
